### ONLINE PRIVACY POLICY AGREEMENT

The length of time we retain said information will be determined based upon the following criteria: the length of time your personal information remains relevant; the length of time it is reasonable to keep records to demonstrate that we have fulfilled our duties and obligations; any limitation periods within which claims might be made; any retention periods prescribed by law or recommended by regulators, professional bodies or associations; the type of contract we have with you, the existence of your consent, and our legitimate interest in keeping such information as stated in this Policy.

#### **Use of Information Collected**

Capitol City Old Car Club does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.

Capitol City Old Car Club may also be in contact with you with regards to completing surveys and/or research questionnaires related to your opinion of current or potential future services that may be offered.

These may collect your IP address and require cookies to work properly. These services are governed by the privacy policies of the providers and are not within Capitol City Old Car Club's control.

#### **Disclosure of Information**

- as necessary to provide services or products you have ordered;
- · in other ways described in this Policy or to which you have otherwise consented;

- as required by law, or in response to a subpoena or search warrant;
- to outside auditors who have agreed to keep the information confidential;
- as necessary to enforce the Terms of Service;
- as necessary to maintain, safeguard and preserve all the rights and property of Capitol City Old Car Club.

### **Notice to European Union Users**

This framework protects the fundamental rights of anyone in the EU whose personal data is transferred to the United States for commercial purposes.
